1. I, _____ ("Client") agree to enter into a contract with Finest Chauffeur's L.L.C. ("The Company") to provide a chauffeur to drive my automobile as requested. I understand Finest Chauffeurs, chauffeurs are not security guards, bodyguards, nor do they provide executive protection.
2. I represent that my automobile is in good working condition and has the appropriate inspection and registration, both which are in effect and have not expired.
3. I represent that the automobile to be used is actively insured for a minimum liability limits of \$250,000 bodily injury each person/ \$500,000 each accident, \$50,000 property damage, collision and comprehensive coverage, There are no driver restrictions, and that there are no restrictions in the policies, and that such policies are in full force and effect.
4. I understand that my vehicle insurance is primary for liability, collision and comprehensive coverage's and that Finest Chauffeur's responsibility is limited to the amount of my deductible or \$500.00 (whichever is less) for physical damage to my vehicle resulting from the negligence of a Finest Chauffeur's driver.
5. I agree to notify Finest Chauffeur's of any changes in the condition of my vehicle, or insurance coverage.
6. I, **hereby release, agree to indemnify, defend, and hold harmless Finest Chauffeur's, L.L.C.**, its officers, directors, shareholders, employees, and independent contractors from any and all claims, demands, suits, liabilities, expenses, costs, judgments, injuries (including death) or other losses or damages which arise from or relate to Finest Chauffeur's, L.L.C. and its officers, directors, shareholders, employees, and independent contractors providing services for me.
7. Finest Chauffeurs LLC, chauffeurs represent its inventory of skilled professionals. If, in the event Client wishes to convert a Finest Chauffeurs driver to the client's employee, Client agrees to pay a conversion fee as liquidated damages. The conversion fee is \$6,000. Liability for the conversion fee is triggered when Client hires a Finest Chauffeurs L.L.C. chauffeur regardless of the employment classification, on either a permanent, temporary or "as needed" basis and regardless of the chauffeur's employment status at the time of the hire (e.g., no longer with Finest Chauffeurs L.L.C.) or chauffeur's claimed reason for leaving Finest Chauffeurs L.L.C. (e.g., quit Finest Chauffeurs L.L.C. for reasons unrelated to conversion) if said hire occurs within six months after the last day of the assignment.
8. Finest Chauffeurs agrees to pay the chauffeurs workmen's compensation, disability insurance and non-owners liability.
9. Finest Chauffeurs agrees to provide the client with a back-up chauffeur when the primary chauffeur is sick or unavailable, when Finest Chauffeurs receives ample notice.
10. Finest Chauffeurs agrees to provide the client with a replacement chauffeur if the client is not satisfied with the chauffeurs' work performance, or for any reason client wishes to be assigned another chauffeur, when Finest Chauffeurs receives ample notice..

11. Client will be billed \$35 per hour. Any chauffeur who drives the client more than 40 forty hours per week, client will be charged \$52.50 per hour thereafter. A holiday rate of \$52.50 will apply to the following days.

New Year's Day, New Years Eve, Martin Luther King, Jr. Day, Memorial Day, Independence Day, Labor Day, Veterans Day, Thanksgiving Day, Christmas Day, and Christmas Eve
12. This Agreement shall be subject to the laws of New York State.
13. If any provision herein shall be deemed to be invalid, the remaining provisions shall remain in effect.
14. This agreement represents the entire agreement.
15. Changes to this agreement may only be made in writing, signed by both parties.
